## **North Versailles Township Ordinance NO. 807**

**AN ORDINANCE OF NORTH VERSAILLES TOWNSHIP PROVIDING FOR THE REGULATION THE PRACTICE OF SOLICITATION IN THE TOWNSHIP, AND PROVIDING LICENSES THEREFORE AND PROVIDING FOR FINES AND PENALTIES IN CASES OF VIOLATIONS. THIS ORDINANCE IS A CODIFICATION AND AMPLIFICATION OF ALL EXISTING ORDINANCES APPLICABLE TO SOLICITING AND PEDDLING.**

### **LICENSE & Some REQUIREMENTS**

***(Note: You should read the entire ordinance this is only a summary)***

On November 15<sup>th</sup> 1982, the North Versailles, Township Board of Commissioners passed ordinance number 807 regulating the practice of solicitation in the Township. If you would like a copy of the complete ordinance it is available at the North Versailles Township municipal building during regular business hours.

Please refer to this brief summarization of the ordinance to ensure that your business is in compliance.

- Obtain a Solicitation permit from North Versailles Township. Forms are available from the Township Manager Office.
- Solicitor – Shall include any person:
  - a. Who goes from private house to house, conveying or transporting goods, wares or merchandise, or offering or exposing the same for sale or making sales or delivering articles, goods, wares or merchandise to purchasers;
  - b. Who goes from private house to house, soliciting or attempting to take orders from individuals for sale of goods, wares or merchandise, including magazines, books periodicals or personal property of any nature whatsoever, for future deliver, or for service to be performed at that time or in the future, whether or not such individual has, carries or expose for sale a sample of the subject of such order or whether or not he is collecting advance payments on such orders;
  - c. Who goes from private house to private house soliciting donations or money for themselves or for any organization for any purpose, whether or not anything of value is given in return.

### **RESTRICTIONS ON TIME AND PLACE**

- A. No licensee shall solicit at any private residences on Sunday or before 9:00 A.M. or after 5:00 P.M. prevailing time, on weekdays.
- B. No licensee shall solicit at any private residence exhibiting a sign reading “No Solicitors” or words of the same meaning.

### **SECTION IX EXHIBITION OF LICENSE**

Licensees shall exhibit their license at the request of any resident or police officer.
